# HCSA Regular Board Meeting May 18, 2023

A regular meeting of the Board of Directors of the Halifax County Service Authority was held on May 18, 2023 at 3:30 PM in the Authority conference room located at 2529 Houghton Avenue in the Town of South Boston, Virginia.

## **Public Comment Period:**

No one registered to address the board during the scheduled public comment period.

## 1. Review of Minutes from the March 16, 2023 meeting

The minutes from the March 16, 2023 business meeting were reviewed by the Board. Corrections for board attendance were revised. Fields Thomas moved to approve the minutes as revised. LaTonya Hamilton provided a second to the motion. The motion passed without opposition.

# 2. Review of the Financial Reports for March and April 2023

The Treasurer presented the financial statements to the board for review and discussion. It was noted that both water and sewer revenues are trending higher than projected. There were no suggested changes or modifications that were noted, required or approved.

# 3. Leigh Street Filter Plant - 2022 VDH VOP Gold Award for Operations

The HCSA Leigh Street Filtration Plant has been presented the highest performance award by the Virginia Department of Health for Operational Excellence in Waterworks Operations Performance Award. The award is a part of the Virginia Optimization Program (VOP) which strives to encourage water treatment facilities to provide water with a quality that exceeds minimum regulatory standards and to operate water systems in an exemplary manner. Operations Director, Bryant Francisco, presented the framed certificate to several of the Leigh Street Water Treatment Plant.

## 4. Board of Directors – Reappointments

Directors LaTonya Hamilton and Hope Harris-Gayles are up for reappointment to serve on the Board for an additional four (4) years. Both Director's terms will expire June 30, 2023. Both Directors agreed to serve an additional term. The next step is to submit both candidates to the localities for approval.

Kathy Bane moved to approve and relay the Board's approval of candidates Latonya Hamilton and Hope Harris-Gayles to the County of Halifax, Town of South Boston and Town of Halifax before their respective June 2023 public meetings. Fields Thomas provided a second to the motion. The motion passed without opposition or additional discussions.

## 5. Water Plant Upgrade - Rate and Finance Study

The Water Treatment Plant Upgrade will need to meet the new Emerging Contaminants (PFAS, PFOA) compliance timeline; EPA expects to finalize the UMCR rule by early 2024.

Staff believes we are currently experiencing our best opportunity to upgrade the plant while grant funds are available and early in the compliance cycle to have a pool of contractors to solicit proposals from. This is an exceptional (highest in the Commonwealth) offer from VDH of \$12,310,053.00 in GRANT money towards this project. I am also anticipating additional grant funds from a USDA RD grant/loan application as well. This is the best opportunity we will have to meet this regulatory requirement and maintain affordable rates. This will be addressed in the budget and rate presentation as we move forward on the agenda.

## 6. Proposed FY 2024 HCSA Rates and Fees Schedule

Staff presented to the board a proposed rate and fee schedule for FY2024 with rates and fees that aligns with the recent Dewberry study. The fee and rate schedule is reflected in the proposed FY 2024 annual budget. Gray Ramsey moved to allow staff to advertise the proposed rates and fees and to schedule a public hearing for July 20, 2023. Fields Thomas provided a second to the motion. The motion passed without opposition as presented below:

The purpose of the public hearing is to receive comments on proposed rate changes and will be held at the Authority's Administrative Offices located at 2529 Houghton Avenue in the Town of South Boston, Virginia at 4:00 PM on July 20, 2023. All Monthly Base Rate charges for Water and Sewer services will increase by \$1.00 for each service provided. The High-Volume Water and Sewer Rate Tier (Usage Above 100,000 Gallons per Monthly Billing Period) will be discontinued.  $All\ consumption\ will\ be\ based\ upon\ the\ same\ rates:\ \$5.00/1000\ gallons\ for\ Water\ and\ \$5.70/1000\ gallons\ for\ Sewer.$ Rates for Fire Suppression Meters will be as listed in the table below.

## Notice of Public Hearing on Proposed Changes to the Halifax County Service Authority Schedule of Rates and Fees

BE IT RESOLVED, that the Halifax County Service Authority does hereby agree to set the following proposed preliminary schedule fixing and classifying rates, fees and charges for water and sewer service and hereby authorizes the Executive Director to advertise a public hearing in accordance with Section §15.5-5.114 Code of Virginal, 1950, as amended, to be held on July 20, 2023 at 4.00 p.m. The purpose of the public hearing is to receive comments on the proposed changes and will be held at the Authority's Administrative Offices located at 2529 Houghton Avenue in the Town of South Boston, Virginia. The public hearing will be advertised two (2) times, six (6) days apart, and at least 14 days prior to the hearing.

All Monthly Base Rate charges for Water and Sewer services will increase by \$1.00 for each service provided. The High-Volume Water and Sewer Rate Tier (Usage Above 100,000 Gallons per Monthly Billing Period) will be discontinued. All consumption will be based upon the same rates: \$5.00/1000 gallons for Water and \$5.70/1000 gallons for Sewer. Rates for Fire Suppression Meters will be as listed in the table below.

The finance committee put forth a recommendation for the board to approve and adopt the FY 2024 annual budget. Kathy Bane moved to approve the FY 2024 Annual budget as presented to the board. Latonya Hamilton provided a second to the motion. The motion passed without opposition.
