1. Review of Minutes from July 20, 2023 Meeting - Chair

2. Review of Financial Reports – Treasurer/ Assistant Executive Director

4. Leigh Street Filter Plant Upgrade Presentation – Executive Director, Dewberry

a. Real Estate Purchase - Staff updated the board on property acquisition needed for the expansion of the Leigh Street Water Plant. Three (3) parcels were transferred and recorded earlier in September. Estate Purchase

b. VDH – Project Engineering and Construction Financing – Dewberry presented an overview of the water plant improvements, including a 3-D rendering of the proposed project modular construction and site locations and conditions. Dewberry also presented an engineering and design proposal for the project as listed below:

Staff also presented the funding available through VDH and through USDA RD. The project is eligible for a Build America Back Again (BABA) exemption due to the date of the PER submittal and funding application(s). The new estimated project cost is \$8,130,000. Below is a table listing the known and expected funding options from VDH and USDA RD.

Additional funding has been allocated for the project through USDA RD low interest loan program. The Authority has been allocated up to \$8,127,000 with 40-year terms and a fixed interest rate of 2.875%. The use of the funds is dependent upon agreement to terms and conditions prior to project construction bid advertisement.

c. Interim Project Design Financing – Staff presented several interim financing options in the amount of \$1,200,000 in order to allow Dewberry to proceed with engineering and design of the project. The amount borrowed for engineering and design is reimbursable to the Authority upon the award of the contract. Staff asked for consent to proceed with interim project funding and to accept the funding offers from VDH and USDA RD as potential project funding sources.

Kathy Bane moved to allow authority staff to borrow \$1,200,000 for interim engineering and design costs from Benchmark Bank by using existing Authority funds as collateral for a one-year Certificate of Deposit (CD) as collateral. The interest on the CD would off-set nearly all of the interest charged for the short-term loan. Daniel Lloyd provided a second to the motion. The motion passed without opposition.

Daniel Lloyd moved to accept the funding offer for the engineering, design and construction of the Leigh Street Water Plant improvements from VDH by accepting the terms and conditions of the twenty-year term offer accompanied with an interest rate of 2.75%. Hope Harris-Gayles provided a second to the motion. The motion passed without opposition.

5. Sinai & VIR Utility Extension Projects – Award of Contract – Executive Director - Staff presented the preliminary results of construction bids received on Thursday, September 21, 2023 at 2:00 PM and 2:30 PM, respectively. The bids will be reviewed for any errors or inconsistencies and the official tabulation and award will be decided at a later date. The projects are contingent and based upon funding by the County of Halifax. The following bid tabulation was presented to the board.

Staff also provided an overview 2020 General Assembly. House Bill 358 and its potential implications for small rural systems. HB 358 allows public works contracts (by locality approval) to authorize project labor agreements.

The Bill allows for local project labor agreements; public procurement and authorizes any public body, including any state or local government, when engaged in procuring products or services or letting contracts for construction, manufacture, maintenance, or operation of public works, to require bidders to enter into or adhere to project labor agreements on the public works projects.

This allowance or authorization can have a significant impact on rural and small system projects that depend upon Virginia's existing "Right to Work" and local prevailing labor rates to control project costs and funding acquisition.

The Board moved to enter a Closed Session pursuant to § 2.2-3711. A. 1, 3 & 6 Code of Virginia 1950 as amended. The specific topic(s) for which the closed session was called for are:
